1. **Meeting Called to Order** by R. Yathon at 6:39 pm

2. Treasurer's Report

- Total funds \$18,876.76
- Interest from December missing as November and December statements were unavailable due to postal strike.
- Motion to adopt treasurer's report as read by R. Yathon. Second by A. Wlock.

3. Principal's Report

- Enrollment at 117
- Upcoming events: 100 days of school, Telemiracle (events organized by SRC and Mrs. Schick), Family Literacy Day- January 27th, Pink Shirt Day- February 27th, report cards- February 3rd, Winterruption- will be somewhere between February 28th and March 14th (hot chocolate dispersal by SCC), grade 6 ski trip with Davison- February 6th
- March Book Madness will be an outdoor theme this year (est. \$12/book x 78 books, comes to around \$1000). Requesting SCC purchase books.
- Future issues for Miller School: school is crowded at 139% building usage- possible solutions to move all grade 6 students from Miller and Davison to MCS (at lower capacity but calculates this using space where instruction does not occur such as hallways) or change Miller boundaries to rural students only (with all current urban students able to stay at Miller). Portable buildings discussed but take a significant amount of time to obtain. A boundary change would be easier to adjust in the future vs moving grade 6 students to MCS. Requested for K. Stav will take SCC discussion and concerns to GSSD board meeting.
- Altered school year in 2026-2027- 10 Fridays off throughout the year with time added onto school days. This would have to be agreed upon by all schools. K. Stav reports that this pilot will not start in Melville due to the complexity of initiating it here. It should be community led, and SCC driven.
